AMONG THE HIGHLIGHTS FEATURED IN THIS REPORT:

TEACHING AND LEARNING

- Received national recognition from the Center of Excellence in Nursing Education for the Practical Nursing program
- Received a \$2.5 million "First in the World" federal Department of Education grant in partnership with Bergen Community College to explore new pedagogies for developmental math.
- Developed supply-chain credit certifications through a \$1.6 million federal Trade Adjustment Act grant.

STUDENT SUPPORT AND ACTIVITIES

- Achieved a graduation rate of 15.7 percent, which is over 5 percent higher than the record set the prior year. Since 2009, Union's graduation rate has nearly tripled, setting an all-time record for graduates in FY 2015 with a total of 1,505
- Held a "doubleheader" of winter commencement ceremonies in the Union County Performing Arts Center in Rahway. The reason for holding two separate ceremonies on Jan. 14, 2016, was to accommodate the more than 250 graduates and their families.
- Launched the "Project Achievement" program to provide "intrusive intervention" to help improve the graduation rates of African-American

EMPLOYEES, FACILITIES, AND TECHNOLOGY

- Opened the Health Sciences building on the Plainfield Campus home to Practical Nursing, Emergency Medicine, and Paramedic Services.
- Launched a new system of College-wide governance to include all faculty and staff as participants.
- Opened two new biology laboratories on the seventh floor of the Lessner building in Elizabeth, funded through a \$1.8 million NJ State "Building" Our Future" capital-construction grant.

UNION IN THE COMMUNITY

- Began a partnership with the Union County Freeholders to manage the Workforce Innovation Business Center, which is a training and jobplacement service located in Elizabeth at the Mills at Jersey Gardens shopping mall.
- Received two \$500,000 gifts to the Foundation's scholarship fund in 2015, from the Betty and Fred Kopf family of Westfield and from alumna Helen Chaney.
- Conducted a job fair that matched more than 500 job seekers with 30 regional businesses.
- Received a \$800,000 federal Trade Adjustment Act grant to support students in healthcare education.



UNION'S PRACTICAL NURSING PROGRAM **EARNS "CENTER OF EXCELLENCE**" **RECOGNITION**

Union County College's Practical Nursing Program earned national distinction in being named a "Center of Excellence" by the National League for Nursing from 2015 to 2019. This recognition is conferred to select nursing-education departments for their longstanding record of achievement in nursing education.



TEACHING AND LEARNING

NEW MATH COURSE IMPROVES STUDENT SUCCESS

In the fall 2015, the College voted to implement a new math course into the curriculum. This course, Math 017, assists with reducing the amount of time previously required to complete the developmental math track.

FACULTY CONVENED FOR THIRD ASSESSMENT DAY

The College's third annual "Assessment Day" was held to investigate innovative approaches to measuring student learning. The keynote presentation was given by Dan McInerney, the Degree Qualifications Profile/Tuning Coach whose Lumina Foundation-sponsored program was titled, "A Framework for Student Learning." In the afternoon, faculty could attend one of the following sessions: "The Basics of Learning Outcomes Assessment," "Discipline-Specific Assessment," or "Using Canvas for Learning Outcomes Assessment." Canvas is the College's new online course system replacing ANGEL. Held at the Cranford campus, the day ended with department meetings.

CANVAS IS THE NEW LEARNING **MANAGEMENT SYSTEM**

To improve online education courses for Union students, the College upgraded the learning management system from Angel to Canvas. During the fall 2015 semester, instructors

were asked to volunteer their time and courses to test out the new system.



Many found it to be very simple to use and all instructors were required to use it in the spring 2016 term.

BERKELEY COLLEGE PARTNERED WITH UNION FOR BACHELOR'S **IN NURSING**

Union has partnered with Berkeley College for an accelerated program for Licensed Practical Nurses to earn their Bachelor of Science in Nursing degree in less than three years. After



several years of development, the program was implemented through the Robert Wood Johnson Foundation's New Jersey Health Initiatives Program, Practical Nurses

with active licenses earn 30 credits for their work in the field toward the BSN degree. Berkeley has already begun enrolling graduates of Union's Practical Nursing program.

FREEHOLDER JALLOH KICKED **OFF "COLLEGE READINESS NOW" PROGRAM**

Union County Freeholder Chairman Mohamed S. Jalloh and Freeholder Sergio Granados joined students on Sept. 9 for the first class in the "College Readiness Now" program. The Freeholder-funded initiative provided an accelerated math "boot camp"-style instruction for students who tested into developmental math based on low scores in Accuplacer placement testing. Union has launched the program with four County high schools: Plainfield High School, Abraham Clark High School of Roselle, David Brearley High of Kenilworth, and the Hillcrest Academy.

STUDENTS COMPLETED BUSINESS **COMMUNICATION CLASS**

This year the Industry-Business Institute provided contract training for G&W Laboratories of South Plainfield. The students in Instructor Wilma Hurwitz's "Business Communication: Communication and Presentation Skills for the Technical Professional," course completed their 40 hours of class on June 17. The students developed their enhanced skills to write business documents including regulatory reports and internal communications.

"GIRLS GONE WIRED" HELD AT UNION COUNTY COLLEGE-RAHWAY

The College was able to offer a free demonstration class to women on how to write computer codes, thanks in part to funding by the Union County Board of Chosen Freeholders. Attendees used iPads for their learning experience that was held at the College's Rahway Center on Aug. 27. The class was taught by Union's Director of Instructional Design Beth Ritter-Guth. At the day's end, each student was able to write code or create an iPad app. Union County Freeholder Bette Jane Kowalski and Rahway Mayor Samson Steinman were among the dignitaries who stopped by to see the class in action.

BACHELOR DEGREE AT UNION

Union County College proposed offering a baccalaureate of science degree in nursing for students who have completed an associate degree or diploma in the nursing program and have passed the examination to be registered nurses. To be eligible for the RN-to-BSN Completion Program at Union, students would need to hold an associate degree in nursing, an associate degree in science, or a diploma in nursing. They would also need to hold a current license as a registered nurse. The program is awaiting approval from the New Jersey Secretary of Higher Education.



DR. KENDALL MELTON WAS **CONVOCATION SPEAKER**

For the 2015 Convocation, members of the faculty and staff were mesmerized by Dr. Robbie Kendall Melton, the Associate Vice Chancellor for Academic Affairs for the Tennessee Board of Regents, which oversees 47 colleges and universities. Dr. Melton specializes in the use of technology in education ("elearning") and is the chief system level administrator to oversee Tennessee's mission and initiatives for the Strategic Mobilization Planning and Business Models, Mobilization Quality Assurances, Faculty and Student Use of Mobile Devices related to teaching, learning, training, and workforce development, and the coordination of research, product testing, pilots and security safety networks. She expressed the importance of integrating technology into education in order to meet the needs of today's learners for tomorrow's technological demands.

STEM STUDENTS PARTICIPATE IN MAKERSPACE PROGRAM

On Oct. 21, Union County College and Kean University held an opening ceremony for the "Possibility Zone Makerspace" at Kean University. The Makerspace provides STEM students a place to work with other students in their field; find tutoring, advising and support services: and work online with various simulation software and career development programs. Makerspace is funded through the U.S. Department of Education Developing Hispanic Serving Institutions (Title V) program and the STEMpact grant is a cooperative project between the College and Kean to improve retention, completion and transfer rates among high-need Hispanic and low-income STFM and Education students. AMERICAN HONORS PROGRAM EXPANDS

In its second year, the American Honors program, a selective honors program for students who plan to transfer to a four-year college or university to earn a bachelor's degree, expanded its enrollment. The program grew from 69 students in its first year to 119 students this year.


COLLEGE OFFERS LINCS PROGRAM

The College began a new program of training in Supply Chain Management thanks to the \$1.6 million federal Trade Adjustment Assistance Community College and Career Training (TAACCCT) Grant

Program. The LINCS program offers a series of eight training modules, each of which leads to an




exam and certification by the Council of Supply Chain Management Professionals (CSCMP). Classes began running in June and issued certificates to 23 participants after the first series of completed courses. Programs were offered at the College's Elizabeth campus to displaced workers and unemployed individuals who were referred by the One Stop Center in Elizabeth. The program prepares participants for jobs at the entry or midrange level depending upon previous experience and prior education levels

PLAINFIELD HOSTS DIESEL DIALOGUE

On Mar. 1, more than 20 distributors and manufacturers of heavy diesel equipment and machinery visited the Plainfield Campus to partner with the College in the training of heavydiesel mechanics. NJ County College Consortium's Executive Director Sivaraman Anbarasan and Steve Johnson of the Associated Equipment Distributors College Diesel Training Programs organized the meeting, which Plainfield Dean Regina Riccioni and Continuing and Professional Education Director Lisa Hiscano hosted. The equipment distributors and manufacturers who attended have an acute need for workers with associate degrees who have a basic working knowledge of diesel electronics and hydraulics. The business owners who toured the garage area of the Health Sciences Building, thought that the space would be ideal for this training. Union would be the first community college to provide this training.

UNION AND BERGEN COMMUNITY COLLEGE RECEIVE A \$2.6 MILLION "FIRST IN THE WORLD" GRANT

The College partnered with Bergen Community College to apply for the US Department of Education "First in the World" grant program to improve graduation rates. Union and Bergen were one of 17 winners nationwide and will split a \$2.6 million award over four years. This program will increase the three-semester retention rates of first time students placing into remedial math and decrease the time to completion of the developmental math course for first-time full-time students.

UNION HAS TWO JACK KENT **COOKE FOUNDATION SCHOLARS**

Nuno Pereira was the first Union County College student to win a prestigious Jack Kent Cooke Foundation Scholarship. Now a student at John Jay College of Criminal Justice of the City University of New York, he will be awarded up to \$40,000 per year to complete his bachelor's degree. Mr. Pereira has his associates degree from Union in criminal justice. The scholarship is the largest private scholarship for two-year and community college transfer students in the country. More than 2,000 students applied for the scholarship and Mr. Pereira was one of the 90 who received the award in 2015.

McDaniel Jeantus was the College's second student to receive the Jack Kent Cooke Foundation Scholarship. He too will receive up to \$40,000 per year to complete his bachelor's degree which he is pursuing at Columbia University in New York City. Mr. Jeantus holds his associates degree in liberal arts. More than 2300 students applied for the scholarship and Mr. Jeantus was one of the 75 who received the award in 2016.



GRADUATION CLASS CONTINUES TO GROW

The success of "Operation Graduation" continued to be evident at the May Commencement Ceremony held at the Harwood Arena at Kean University. More than 600 graduates participated in the ceremony and more than 2,000 guests were in attendance to cheer them on. Student speaker Stephen Clark gave an inspirational speech to his fellow graduates. The graduates were welcomed by Board of Trustees Chair Victor Richel. Three special awards were presented during the ceremony. The coveted Alumni Prize was awarded to Michael Osiecki. The presentation of the Post-Day Award was made to the graduating students who best exemplify the College's ideals of scholarship, leadership, and service and this year's recipients were Mr. Osiecki and Erika Ranael.

A SUCCESSFUL WINTER COMMENCEMENT

Union celebrated more than 250 students at the second Winter Commencement ceremony held on Jan. 14. More than 2,000 proud family members and friends attended the two ceremonies at the Union County Performance Arts Center. With more students knowing that a ceremony would be held in January, more students were eager to complete their degrees in August or December.

Throughout 2015, many students took advantage of the College Level Examination Program. The test is provided through the College Board and if passed, can save a student the time and cost of a class. The exam is taken online and is available in 33 subject areas within five categories: History and Social Sciences, Composition and Literature, Science and Mathematics, Business, and World Languages.

THE COLLEGE SETS AN ALL-TIME RECORD FOR NUMBER OF GRADS

The College's Class of 2015 was the most successful graduating class in the College's 82-year history. The total number of graduates hit 1,505. That's 200 more than last year's record. The graduation total was nearly twice as many as five years ago. In addition, the three year graduation rate nearly tripled.

One of the exciting events held this year during Black History Month was an afternoon of song, dance, inspirational speeches, and a touching tribute to Assemblyman Jerry Green for his exemplary record of service in the NJ Assembly

and to the Union County community. He was awarded the Chester Holmes Humanitarian Award for his service. Co-sponsored with the Union County Board of Chosen Freeholders, the celebration attracted students, staff, and elected officials from across the state. Freeholder Linda Carter presided over the ceremonies and thanked the College for its service to the community and close partnership with the County Freeholders. Two students (Kevin Steele and McDaniel Jeantus) earned standing ovations for spirited speeches in which they reflected their experiences as African-Americans. Business and political strategist Tara Dowdell served as keynote speaker, while the Bufford School of Music performed a retrospective medley of African-American songs and dances. Both Ms. Dowdell and the Bufford School encouraged the audience to embrace their roots in celebration of Black History Month. The elected officials in attendance to honor Assemblyman Green included US Congresswoman Bonnie Watson Coleman, State Senator Raymond Lesniak, Senate President Stephen Sweeney, Senator Thomas Kean, Assemblywoman Nancy Munoz, Assemblyman Jamel Holley, Assemblyman Jon Bramnick, Union County Freeholders, and the mayors from more than a dozen Union County towns. The event was held on Feb. 17 in the Roy Smith Theater at the Cranford campus.

UNION STUDENTS ATTENDED LOBBYING DAY IN TRENTON

For the New Jersey Council of County Colleges Lobbying Day, President McMenamin gave the welcome speech at the Wyndham Hotel in Trenton to kick off the day's event. Seven Union County College students were joined by College Relations Executive Director Ellen Dotto and Dean of Students Dr. Terrence Hardee to attend the day's events. The students met with each of the following legislators and had the opportunity to ask them for their continued support for community colleges: Senator Raymond Lesniak; Senator Tom Kean, Jr.; Assemblyman Jerry Green; Assemblyman Jamel Holley; and Assemblywoman Annette Quijano. The students asked the legislators to continue support for community colleges which are underfunded compared to other sectors of higher education; support for NJ Honors Scholars; and to support bachelor's degrees at community colleges.

One of the most comprehensive initiatives developed between the County's "Union County Means Business" and the College was the establishment of the Workforce Innovation Business Center in the City of Elizabeth. The ribbon cutting ceremony was held on Apr. 21 to an audience of 500 of local business owners and job seekers, along with local dignitaries such as Freeholder Chairman Mohamed Jalloh, State Senator Raymond Lesniak, and Elizabeth Mayor J. Christian Bollwage. The College's President Margaret M. McMenamin was the featured speaker for the event. She said that the WIBC was "a testament to the vision of the County Freeholders. Through the Center, the College is able to increase the County-wide job readiness and employee productivity, provide occupational training, basic skills and basic skills and literacy courses." Also, for every unemployed and under-employed resident seeking services, the College's staff administers a 40-hour soft skills training course that the College's Industry-Business Institute developed with the Workforce Investment Board. The College also provides assistance to clients needing legal consultation for citizenship through the AFL-CIO, on-the-job training through the Elizabeth Development Corporation, entrepreneurship assistance by the Union County Economic Development Corporation, and youth services through the Barack Obama Green Charter High School.

UNION STUDENTS HELPED CHANGE HUNGER

This year's Student Government Association was very driven to host charity type events and to provide outreach assistance, if possible, in times of need. During October and November 2015, the SGA and the Psi Beta Honor Society joined together and participated in Students Change Hunger, an initiative to bring food to families throughout the State of NJ, where one in every five children go to bed hungry most nights. Union's students delivered the College's donations to The Community FoodBank of New Jersey in Hillside. The Foodbank raised more than 44 million pounds of food. The total pounds of food donated by Union throughout the month was 1.392.

STUDENTS PARTICIPATED IN HOLIDAY HELPERS PROJECT

Sport Management Assistant Professor Marc Postiglione led students in a community-service project in December to assist St. Joseph's Social Services in Elizabeth with their annual Holiday Helpers Project. This Project coordinates the donation of holiday items from churches throughout Union County and gives them to families and children in need. FIRST SOFT-SKILLS GRADUATES

The Workforce Innovation Business Center is a College-run facility that assists with helping to train residents with necessary skills to find work. Since its inception, the Freeholder-led initiative has provided jobs for nearly 300 residents. A key feature of the center is the development of a 40-hour soft-skills training course that the College's Industry-Business Institute developed in conjunction with the Workforce Investment Board and several County businesses. The College has provided the job-readiness training for 120 residents prior to their being place in jobs. METAL FABRICATION/ **CNC MACHINIST** TRAINING PROGRAM

The Metal Fabrication/CNC Machinist training program provides training for high-tech jobs in advanced manufacturing. The ten week program includes instruction in the use of lathes, milling equipment, CNC equipment, grinding equipment, blueprint reading and more. Twenty-one students completed the program and sat for the National Institute for Metalworking Skills Machining Level 1 exam, several with offers of employment. This training is



made possible by a US Department of Labor National Emergency Grant awarded to the State of New Jersey Department of Labor and Workforce Development and a US Department of Labor H1-B Ready-to-Work Partnership Grant awarded to the NJ County College Consortium for Workforce and Economic Development. Mobile curriculum and resources provided by United States Department of Labor Round Two TAACCCT Grant through Camden County College.



PITTS RECEIVED DIPLOMA **35 YEARS LATER**

Alan Pitts proved that it's never too late to graduate. WOMEN'S BASKETBALL TEAM ARE **AGAIN NAMED REGION XIX CHAMPIONS**

For a second year, the Women's Basketball team were named the Region XIX Champions by beating Harcum College by a score of 91-75 on Feb. 28. Sophomore Guard/Forward Shaniece Wright was named tournament MVP and Head Coach Cheryl Bell was named Region XIX Coach of the Year. The win qualified the team to head to the national tournament held in Kansas in March.

TRACK AND FIELD RANK AT **NATIONALS**

The Union County College Track and Field team had an excellent performance at the NJCAA National Championships at Holyoke Community College in Massachusetts from May 6-8. Iyanah Hawley, of Elizabeth, won multiple events and broke NJCAA national meet records. Ms. Hawley finished first in the 100 and 400 meter hurdles, running the 100-meter hurdles in 14.44 seconds, setting a new NJCAA record. She was named the Female Eastern Region Athlete of the Year. Led by Nolister Montas, of Summit, the Men's team also excelled. Montas placed 4th in the javelin throw with 48.48 meters. Union's team also came in sixth for the Men's 400-meter hurdles. The Men's also finished sixth in the 4x100-meter relay. Since its 2012 founding, the College's Track and Field program has boasted more than 30 All-Americans.



LACROSSE TEAM WON REGIONAL CHAMPIONSHIP

In only its fourth year, Union's men's lacrosse team won the Region XIX Championship. The team had an incredible season, finishing their regular season with a record of 15-2. They defeated all Region XIX teams by at least 10 goals each game. Five players earned national recognition, and the team ranked in sixth-place in the National Junior College Athletic Association. Cranford's Jay Roussey coached the squad, which featured leading scorer Mark Swintek, whose 130 points were the most in the USA. Goalie Cole Weber of Scotch Plains had the nation's lowest goals-against average. Other stalwarts included Midfielder Mike Flood, Defender Ryan Marsh, and Defender Mark Trinkle of Westfield; Defender Anthony Perrone, Midfielder Brett Scaturo, Midfielder Mike Palumbo of Cranford; and Midfielder Jake Egner, Defender John Atansio, and Defender Sean Quigley of Clark; and Midfielder Steven Clarke of Berkeley Heights. Union County College hosted and won the 2016 Region XIX Tournament. The Owls triumphed over Delaware Technical Community College in the semifinal by a score of 20-3. In the Championship game, the Owls defeated Ocean County College 13-7.



The ALC provides tutoring services on all three campuses to support student success and last year delivered over 60,000 individual tutoring sessions for a total of more than 68,000 hours of student assistance. The ALC employs more than one hundred of our high achieving student "peer" tutors who earn work-study income while providing tutoring support in mathematics success centers and in any subject topic area such as biology, chemistry, psychology, engineering, and English.



STUDENT SERVICES BUILDING **SCHEDULED TO OPEN MID-2016**

The superstructure of the newest building on the Cranford campus in 20 years continued to progress through 2015 and is scheduled for a 2016 opening. The new "One Stop" will be a welcoming gateway for new students and a successful solution to the entire registration process for current students. Everything our students need will be out in the open on the first floor with cross-trained, multi-tasking staff on hand and ready to serve.

The Union County Improvement Authority is managing construction for this \$14 million, two-story, 30,000-square foot building. The footprint extends from the Nomahegan and Humanities buildings into the grounds located in the courtyard next to the MacKay Library.

The new building's first floor will feature "One Stop" services to admissions, registration, financial aid, student accounts, and advising. On the second floor, the building will address the College's need for additional classrooms and faculty offices. The project will also include the renovation of 6,000 square feet of existing space in the offices that the Advisement, Counseling, and Transfer Services Department formerly occupied

Union will unveil the new building during the summer of 2016 in advance of the start of the Fall 2016 semester. Not since the 1995 completion of the Campus Center "Pavilion" (where the Executive Education Center and the Fitness Center reside) has the College built a new structure on the grounds of the 48-acre campus.

Dr. Hawthorne will use the funds to develop a new computer science/cybersecurity course for community colleges. Union is one of the grant's pilot institutions, making it one of the first to offer the course.



CONGRATULATIONS TO PROFESSOR HEIDARY

Sherry Heidary, Assistant Professor of Chemistry, received an Excellence Award from the National Institute for Staff and Organizational Development of the University of Texas. She received her award at the International Conference on Teaching and Learning Excellence held in Austin, Texas.

Robert Yoskowitz, Senior Professor of Fine Arts, had his illustrated poster "The First Annual Ernie the Chicken Festival," featuring Bruce Springsteen at Newark State College (now Kean University) in May 1971, enshrined in the Rock and Roll Hall of Fame in Cleveland, Ohio. GOVERNANCE BORN ON JULY 1

A new system of governance officially began at Union County College on July 1 when the new rules of the Governance Leadership Council (GLC) went into effect. President McMenamin emphasizes that the new Governance system is "for faculty, staff, administrators and students—an opportunity for everybody to be heard, to have a vote, and to have input into the governing of the College." The role of the GLC is to oversee and manage all aspects of College Standing and College Professional Evaluation Committees, prepare an annual report for the President, meet with the President or designee to receive annual charges, meet with committee chairs/committees to solicit input regarding committee work, and evaluate committee functions and membership when requested and make recommendations to the President. The GLC will assign charges to the 17 standing committees. College assemblies will be held to feature committee presentations and reports on specific areas of interest or individual charges.

UNION RECEIVED AWARD FROM NATIONAL SCIENCE FOUNDATION

The National Science Foundation (NSF) announced an award of \$199,987 to Union County College from the Advanced Technological Education (ATE) grant program for a two year project to create and pilot a Cyber Forensics Technician program. Dr. Elizabeth Hawthorne is the lead on the project and is working with Dr. Cynthia Roemer. Project goals include: addressing the need for an increasing number of skilled cyber forensics technicians; improving student retention to complete a post-secondary credit certificate and/or an associate in applied science degree; and preparing graduates with career ready skills.

SUMMARY & OUTLOOK

The support of the College is dependent on three major revenue sources: State Appropriations, County Appropriations and student tuition. During economic times when increases for State and County Aid are tight, greater pressure falls upon students to bear the additional cost in the form of increased tuition. The College continues its efforts to contain costs so as to curtail and manage student revenue increases.

Looking forward begins with student enrollment growth which is dependent on an array of factors including population growth rate, unemployment rate, and the number of high school graduates in Union County and the surrounding areas. During FY 2015 student academic credit hours decreased 4.0% from FY 2014 and the Fall 2015 enrollment has decreased 2.7% compared to the preceding Fall semester. It is expected that this trend will continue throughout FY 2016.

As mentioned above, management continues to place great emphasis on cost containment to mitigate rising costs and to minimize tuition increases. Ongoing concerted efforts have been made to utilize part time instructors where feasible to control instructional spending. The institution has realized the benefits of this initiative since FY 2013 along with class consolidation and higher utilization of classroom capacity. This has been an ongoing process and will continue throughout FY 2016.

An organizational structure in Academic Affairs was needed to provide twelve month accountability and administrative support. Managing the complexity of day to day operations in higher education today requires a full time presence over the entire calendar year. The previous structure had all ten Departments, eight Department Chairs and all 160 full time faculty members reporting to the Academic Vice President, an approach that did not support quality teaching and learning.

Effective July 1, 2015, a reorganization in Academic Affairs took place to provide a structure that links together like disciplines, encourages innovation, focuses faculty and staff on organizational priorities and goals, and promotes student success. The revised structure consists of four Divisions: Humanities; Social Sciences, Business and History; STEM; and Allied Sciences each headed by a dean. The faculty report to their respective Dean. Each Dean is supported in the administration of their responsibilities by Assistant Deans and Directors.

The College had a need to integrate all student service functions within one division. With the consolidation of all of these functions particularly with the One-Stop Center on the horizon, students would be provided with consistent communication from the institution's team approach for addressing student issues in a comprehensive and dynamic single location environment. With this in mind, effective October 1, 2015, a reorganization within the Student Development division took place. Admissions, Records and Registration as well as Student Accounts became a part of the division. The role of One Stop Managers was developed and became a part of the division's structure along with a new Dean of Student Success and a reorganization with respect to the role of the Dean of Students. With all of this in mind, the goal of this

> reorganization was to provide a premier student service experience in a student-centered environment.

The increasing influence of external pressures and the need to improve student success outcomes have made it essential that decisions invoke interdisciplinary thinking, involve all stakeholders, and reflect an informed, objective, and disciplined perspective. As a result, a new governance structure was instituted to incorporate cross functional input into the decision making process at the College. Including the Governance and Leadership Council, there are eighteen established committees. In addition, there is a monthly College Assembly which through its representative sample of the College community, and its commitment to institutional

priorities provides an interactive forum in which governance becomes a dynamic process that both questions and respects committee work and provides objective input and guidance that is considered in final committee recommendations.

The College continues to expand, renovate and improve facilities and this will continue throughout the up and coming fiscal years. The Student Services Building in Cranford has an anticipated completion date of July 15, 2016. Part of the first floor will be a 'One Stop' multi-purpose space. The second floor will provide twelve classrooms as well as conference rooms and office areas. The Elizabeth Bookstore is being relocated to the Kellogg Building which has an expected completion date at the end of September 2015. Follett with provide fit-out details for the new space. The Annex-Logos renovation should begin Summer/Fall 2015 with the Annex complete by the end of April 2016 and Logos by September 2016. The CCTV Phase II project which will take place during FY 2016 will provide broader coverage and oversight of the exterior portions of the Cranford campus as well as parking Lot #1 to ensure operational continuity. Phase I of this project installed cameras for the interior portions of the Cranford campus as well as the service for the repository for the video footage. Work on the replacement of the heating, ventilation and air conditioning (HVAC) units located in the Science building of the Cranford campus will to be started in the Fall 2015 and it is expected that work will be scheduled throughout the year to replace other old aging systems throughout the campus. The construction plans and specifications are under development for the first and lower levels at the Lessner Building in Elizabeth.

The Information Technology (IT) department has plans for many initiatives to take place in the very near future. Some of these planned projects are an online catalog, an updated College website, upgrading and implementing new technologies to support the "One Stop," IT infrastructure installation and services for the College's various construction projects mentioned above as well as uparadina computer labs.

The College continues to maintain most of its liquid assets in cash. At fiscal year end the cash position of the College is seasonally high to prepare for payment of continued operating expenses during the months before the next significant influx of tuition and grant monies. Interest rates have remained relatively level over the last three years and we do not expect a turnaround in rates during FY 2016

With ongoing cost considerations paramount and continued support from the State and County of Union, the College expects that it will be able to continue to provide an affordable, high quality education to its students. With the plan for enhanced and expanded facilities coupled with the plan for a "One Stop" student service facility on both the Cranford and Elizabeth campuses, the College will continue to assure that the quality and extent of services provided to students will meet their needs and expectations.





Dear Friends,

This past year the Union County College Foundation experienced great progress in support of our mission. Because of your generosity, the Foundation continues to be the leading source of scholarship and emergency support for our students. I know firsthand how your commitment to our students made a real and lasting difference.

For example, nearly 25% of last year's graduating class of more than 1,500 students would not have attended college, let alone graduated, without your support. The Foundation last year provided almost \$1,000,000 in scholarship support to nearly 600 students.



As Betty said, "Union County College helped my son and continues to help thousands of County residents each year. Setting up a scholarship fund will ensure that future generations of County residents benefit from the service that the College provides."

The Kopfs made good on their promise and this past summer donated \$500,000 to the Foundation. This generous donation was used to set-up the Kopf Family endowment that will provide annual funding for two completion scholarships, two general scholarships and five scholarships for part-time students.

The one constant for the scholarships, and in keeping with the Kopfs' intention to "give to their local community college," is in ensuring that every scholarship recipient is a Union County resident.

"Union was a springboard for me in higher education," Helen Chaney said. "The college gave me my start, so I see this gift as my way of helping students financially so that they can afford not only to attend college but also succeed in getting a college degree."

A 1948 graduate, Chaney donated \$500,000 in December and it will support a number of different scholarships and student-success programs. Along with a new endowed scholarship, Mrs. Chaney will also help support the

Foundation's three new student success campaigns, Close the Gap, Operation Graduation & the STEM Revolution. Appropriate to the student-success focus of the gift, the college will name its new student center in Chaney's honor. This center comprises the first floor of the Cranford campus' student services building, a new facility that is scheduled to open in summer 2016.

The Helen E. Chaney Student Center will serve as the focal point for all student services, including admissions and registration, advising, student accounts, financial aid and academic records.

Scholarships and Awards

Why are scholarships so essential? A wide variety of our students are in need of financial assistance to attend the College. A scholarship not only helps to provide the opportunity of higher education to students who can't afford it, but it also assures them that someone believes in their potential. With the support from dedicated alumni and friends, we are able to give students the chance to continue their education and achieve their goals.

An endowed scholarship is self-perpetuating when at least \$25,000 is contributed to the fund. After one year, an endowed scholarship generates 5 percent interest per year, in perpetuity, (in accordance with the Union County College Foundation's spending policy), without reducing the principal. For example, a \$25,000 scholarship provides \$1,250 for students each year, every year, forever.

An Annual Scholarship can be created with a minimum gift of \$1,000. These need to be replenished each year to continue to actively support students.




Union County College Foundation Launched Three New Campaigns for Student Success





UNION STUDENTS HELPED CLEAN **UP NOMAHEGAN PARK FOR EARTH DAY**

In honor of Earth Day 2016, the Advising, Career and Transfer Department gathered a group of student volunteers to clean up Nomahegan Park in Cranford. For two hours on April 22, the students, joined by a few members of the ACT staff, crossed the street from the Cranford campus and helped beautify the environment with trash pickup. The group of more than 10 students filled more than a half dozen bags of trash in the course of two hours.

NUMBER 1 IN ADULT BASIC LITERACY AND EDUCATION GRANT/WORKFORCE DEVELOPMENT

The College's Center for Economic and Workforce Development is NJ State's top-ranked adult-education consortium, according to the Department of Labor and Workforce Development's Report Card on Workforce Investment Act Title II State-wide performance for program year 2013/14. During the year, CEWD oversaw the \$1.3 million ABLE PLUS WIA Title II Consortium with four partner service providers. The consortium served more than 2,500 of the County's neediest residents with classes in Basic Skills, ESL, ESL Civics, high-school equivalency and job preparation. The report tracks the participants' educational gains in their classes as well as "follow up" measures including their success in entering and retaining employment, their pass rate for earning high-school equivalency and in entering college or occupational training programs. More than half of the cohort found employment—almost twenty percentage points higher than the State benchmark. Among the 17 consortia throughout the State, the overall grade was C, and the College consortium earned an "A," reflecting an excellent level of performance and enabling the College to serve as a model for other institutions.



UNION COUNTY COLLEGE HISTORY

1933: Union County Junior College was founded on Oct. 16 and offered only evening classes. It was housed in Abraham Clark High School in Roselle.

1934: Dr. Hubert Banks Huntley became first chief administrator of Union County Junior College.

1935: Dr. Charles G. Cole succeeded Dean Huntley as head of the College and is considered the first "President."

1936: Union County Junior College is established as a non-profit institution governed by a Board of Trustees on Jan. 7.

1936: The College changed its name to Union Junior College.

1940: Basketball was the only sport at the College and the '39/'40 girls' basketball squad take first place in the "Powderpuff League." This was the first championship for a UJC team.

1941: The College began offering days courses on Sept. 1 and continued to use the laboratories at Abraham Clark High School.

1942: The College moved its day operations to the former Grant School in Cranford and rented the space from the Cranford Board of Education.

1944: To better accommodate returning veterans from WWII, the College created a Veterans Study Center and changed the academic year from two semesters to one divided into four quarters.

1944: Dr. Kenneth Campbell MacKay, who was dean of the day school, succeeded Dr. Cole.

1948: For less than \$56,000, the Board of Trustees authorized the purchase of 56 acres from the Dreyer family in Cranford. A decade later it would be the home of the Cranford campus.

1949: Elizabeth General Hospital began its affiliation with the College in the training of its nurses on July 1. Later, Muhlenberg Hospital also participated in a partnership to provide nursing students their pre-clinical course requirements. Elizabeth General is now the Trinitas School of Nursing and Muhlenberg Hospital Nursing School is now the JFK Medical Center Muhlenberg Harold B. and Dorothy A. Snyder Schools, and both still operate cooperative programs with Union County College.

1958: A Development Fund Campaign was initiated on Oct. 1 to raise \$1 million to build a Cranford campus.

1959: The Nomahegan Building was completed on July 15 and the College moved its operations to the 48 acre campus in Cranford.

1967: The word "Junior" was dropped and the College is officially known as "Union College."

1968: Dr. MacKay stepped down as President and was succeeded by Dr. Kenneth W. Iversen, who served until 1974.

1970: The College began holding classes in Elizabeth at the Bayway Community Center and the Elizabeth YMCA on Aug. 5.

1970: The College began offering classes in Plainfield on Sept. 2.

1973: MacKay Library opened on the Cranford campus.

1974: Dr. Saul Orkin became President and served until his untimely death in 1983.

1977: The Women's Basketball team was named Region XIX Champions.

1982: Union College was merged with the Union County Technical Institute and Union County College was established on Aug. 17.

1983: Dr. Derek N. Nunney was named President.

1989: The College acquired the Elizabethtown Gas building on West Jersey Street in Elizabeth.

1990: Dr. Thomas H. Brown became President.

1991: The Campus Center, now known as the Victor M. Richel Student Commons, was opened on the Cranford campus.

1992: The College purchased the former Courier News building in Plainfield on Aug. 17 and began offering courses in the newly renovated building.

1992: The Elizabeth campus was opened on Sept. 1. The former Elizabethtown Gas Company building was named the Lessner Buildina.

1994: Renovation in the lower level of the MacKay Library in Cranford was completed in June and a state-of-the-art Visual Arts and Communications Center was opened. The College partnered with Rutgers (then the University of Medicine and Dentistry) to open a Health Technologies Building in Scotch Plains and offered joint programs in the health professions.

1995: "The Pavilion" was added on the Cranford campus which included the Fitness Center and the Executive Education Center.

1999: The Annex Building was completed on the Plainfield campus. It housed instructional space for the American Sign Language and the Emergency Medical Technician/ Paramedic Programs.

2002: Trinitas School of Nursing moved to the Lessner Building from its hospital-based setting.

2006: The renovation of the MacKay Library in Cranford was completed, having added a third floor of instructional space to the building

2007: The Union County College Foundation completed a capital campaign that raised \$8 million for capital construction and student scholarships.

2009: Thanks to the generous support of the Union County Board of Chosen Freeholders, the College opened the \$48 million Elizabeth I. Kellogg building on West Jersey Street on Sept. 29.

2009: The Men's Soccer Team was the first in the College's history to win the National Junior College Athletic Association (NJCAA) Division III, National Championship.

2010: Dr. Margaret M. McMenamin, the College's eighth and first woman president, began her tenure at Union on July 1.

2011: The Paralegal Studies Program was granted approval by the American Bar Association.

2012: The Middle States Commission on Higher Education approved the College's Periodic Review Report by reaffirming the College's accreditation and commending the institution for the quality of the report and the process of the review.

2013: New athletic teams were established – Men's Lacrosse and a Men's and Women's Track team as well as a Men's Cross Country team. The College revamps its mission statement to "Transforming our Community, One Student at a Time," to accurately reflect the nature of the environment at the three campuses.

2013: The College celebrated its 80th Anniversary on Oct. 16. The College hosted a ribbon-cutting ceremony in the lobby of the newly acquired Thul Auto Parts Building on Nov. 22, across the street from the Plainfield campus.

2014: The College hosted its first Winter Commencement Ceremony on Jan. 14 for students who completed their degrees in August and December. The College held a groundbreaking ceremony for a new Student Services Building on the Cranford campus on Oct. 9. This project was made possible through the support of the Union County Board of Chosen Freeholders and the Union County Improvement Authority.

2015: The College expanded its reach in the community when it held a ribbon-cutting ceremony in Rahway, at 1591 Irving Street, next to the Union County Performing Arts Center. This location hosts continuing education and humanities courses.

2015: Thanks to the NJ State "Building Our Future" capital construction grant, two new biology laboratories were added to the seventh floor of the Lessner Building at the Elizabeth Campus.

2015: The Women's Basketball team was again named the Regional XIX Champions. Head Coach Cheryl Bell was named the Donna Herron Division II Coach of the Year

2015: The College held a ribbon-cutting event at the Plainfield Campus to open the Health Sciences Building on Oct. 20. This building houses the Practical Nursing, Emergency Medical Studies, and the Paramedic program.
